**To: Weissach Performance Ltd. (“Weissach”) Customers,

As you may be aware, in an effort to respond to the privacy concerns of British Columbians, the B.C. Government enacted the Personal Information Protection Act, which came into effect on January 1, 2004. The purpose of this privacy legislation, in general terms, is to regulate the private sector's collection, use and disclosure of personal information. Weissach is committed to protecting the privacy, confidentiality, accuracy and security of your personal information. This letter is to provide you with information on how we are responding to this legislation.

In order to provide our products and services, we require specific personal information. As a result of your relationship with Weissach, for example the purchase/lease/finance of any of our products or services, the service of your vehicle or your participation in one of our surveys, contests or promotions, Weissach may have collected some or all of the following personal information from you:

- Your name, address and telephone number;
- E-mail address and facsimile number;
- Your occupation;
- Information such as preferred car size, color, type of vehicle, kilometers driven annually, etc.;
- Information about your existing vehicle(s) and any trade-in;
- Details of your vehicle and its service history;
- Your driver's license number;
- The name of your insurance company and agent;
- Your or your family member's insurance policy number and details about insurance coverage;
- Your or your family member's social insurance number;
- Your language preference;
- Your or your family member's date of birth;
- The principal amount of your loan, interest and repayment schedule;
- Health information (if you applied for life, health, disability or accident insurance);
- Details of any life, health, disability or accident insurance;
- Financial information, including banking and credit card information;

Why do we collect this personal information? This personal information may be used by Weissach to identify you, to administer products or services you may have with Weissach, such as your vehicle lease financing, to manage and develop our business, and to communicate information to you about the products and services of Weissach and other products and services that may be of interest to you. To facilitate our relationship, we may share your personal information with third parties such as our computing and marketing service providers, the manufacturer of your vehicle and its related financial institutions or financing companies, your insurance agent or company and companies which provide or insure warranties relating to your

vehicle, as may be reasonably required. We may also disclose your personal information where we are required or permitted by law to do so.

Our use of your personal information is always in a manner consistent with applicable laws. Your personal information will only be used for purposes disclosed to you and for which we have gathered your prior consent. Should Weissach need to use your information for purposes other than those already listed, we will explain the purpose to you and obtain your consent – before we use it.

Weissach is committed to maintaining the security of your personal information. Only authorized personnel have access to your information. Our physical and technological systems and procedures are designed to prevent the loss, misuse, unauthorized access, disclosure, alteration or destruction of your information. We retain your information only as long as it is required for the purposes for which it was collected and for any legal or regulatory requirements.

If you are comfortable with personal information use as described above, we thank you for your continued vote of confidence and you need only retain this letter for your records.

If you wish to withdraw your consent for us to use your personal information to communicate with you about products and services that may be of interest to you, please complete the enclosed form and return it to us. If you wish to withdraw your consent for any of the other uses and disclosures described above, or if you have any other concerns, please contact our Privacy Officer.

For now, what we will do is continue to use your information as we have described in this letter and in a manner consistent with your original consent given when you requested our product(s) or service(s). If you change your mind, please contact us. We are glad to share any additional information you may require.
